THIRD AMENDMENT TO AMENDED AND RESTATED DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR RIVER PLANTATION

WHEREAS, CL Realty, L.L.C., a Delaware limited liability company, is the Declarant of the Amended and Restated Declaration of Covenants, Conditions, Restrictions and Easements of River Plantation (the "Declaration"); and

WHEREAS, the Declaration provides for the creation of the River Plantation Homeowners' Association, Inc. (the "Association"); and

WHEREAS, the Declaration was recorded in Official Record Book 1979, Page 2983, and amended by that certain First Amendment to the Declaration recorded in Official Record Book 2000, Page 7715, and by that Second Amendment to the Declaration recorded in Official Record Book 02042, Page 7625, all of the Public Records of Manatee County, Florida; and

WHEREAS, Manatee County and other regulatory agencies have imposed conditions as to the use of the irrigation system; and

WHEREAS, the afore-mentioned Second Amendment contained certain minor irregularities that were not satisfactory to the Southwest Florida Water Management District; and

WHEREAS, in order to comply with such conditions and to correct the irregularities, the Declarant is deemed appropriate and in the best interest of the Owners to amend the Declaration.

NOW, THEREFORE, the Declaration is amended as follows:

- I. Article VI, Section 31, is hereby amended by the addition of the following sentence:
 - "The use of the irrigation system is more particularly set forth in Section 35 of this Article."
- II. Article VI, Section 35(g) and Exhibit "I" are hereby deleted in their entirety and replaced by the following:
 - "(g) Each Lot will be provided one 1-inch PVC ball valve for the source of the irrigation service. These ball valves will be capable of providing 15 gallons per minute (GPM) at approximately 50 pounds per square-inch (PSI). The residential irrigation system design must conform to these specifications in order to be compatible with the mainline system. Water days are confined

to one day per week per lot according to the address of the residence. Newly planted landscape material may be watered on any day for a period of 60 days between the hours of 12:01 a.m. and 10:00 a.m., or 4:00 p.m. to 11:59 p.m. (The waters hours are in compliance with the watering restrictions in Manatee County and the watering restrictions of the Southwest Florida Water Management District (SWFWMD)). A watering schedule throughout River Plantation shall be established by the designation of three (3) irrigation areas as reflected on Exhibit "I", attached hereto."

Except as specifically provided herein, all remaining terms and conditions of the Declaration shall remain in full force and effect.
